Currently the main issue they have been asked to advocate for at the May Advocacy in Action effort (previously called Storm the Hill) concerns burn pits. The issue is Comprehensive Toxic Exposure Reform. The burden of proof is on the veteran to prove that they have been exposed to burn pits. As of right now there is no requirement for the VA to report the cases. MOAA wants to help advocate for the veteran to ensure that the cases are being reported properly.
